Cynthia Sherwood requested that the evaluations be shared with the Board of Trustees. Dr. Bowhay presented Faculty Senate with an ERT update, and KBOR OER options were presented by Toni Bruington and Sarah Owen. Brett Bertie, Benny Beurskens, and President Jordan discussed security concerns associated with RFID keyless entry to campus facilities with the group. Division Chair elections take place in April. Attendees were reminded of the Art Majors Exhibition March 26<sup>th</sup> through May 10<sup>th</sup> in the Black Box Theater and Fine Arts Building hallways. Guest artist, Robert Radliff, with hold a 7:30 p.m. recital Friday, March 19<sup>th</sup>, in the Inge Theater, and the Orchestra Concert is scheduled March 22<sup>nd</sup> in Memorial Hall.
- B. KACCT Update Norman Chambers provided an overview of the KACCT meeting, CARES funding and guidelines, and TEA discussions; Cordell Jordan added additional information. Cynthia Sherwood recognized ICC's PTK Honoree, Azim Bazarov.

#### **Judicial Committee By-Laws**

- 3. Conduct Consult on select disciplinary hearings;
- 4. Hear student appeals; and
- 5. Prepare a one-page summary of the effectiveness of its work for the Council of Chairs.

#### **Conflict of Interest**

In the event that a conflict of interest exists with regards to the persons involved in the disciplinary process, the committee member will be excluded from the process and the designated substitute will perform the duties of that individual.

#### **Disciplinary Hearings**

Judicial Committee Role: This committee is responsible for hearing and considering alleged violations of Student Code of Conduct and Residence Life Rules (excluding Title IX situations) and appeals of academic integrity decisions. Cases will be referred to the Judicial Committee by the VPSA, VPAA, Director of Student Life and Residence Life Director.

In cases of alleged violations of the College's Student Code of Conduct and Residence Life Rules, the role of the committee will be to hear cases and appeals and to make disciplinary decisions. Cases involving suspension or expulsion will be referred to the VPSA for final determination.

In cases of alleged violations of the College's Academic Integrity policies, the role of the committee will be to hear appeals from the VPAA and render a final decision on each individual case. Cases involving suspension, expulsion, or withdrawal from a class with XF will be referred to the VPAA for final determination.

#### **Hearing Format**

Hearings will be private (limited to Complainant(s), Respondent(s), incident witnesses, hearing advisers, members of the committee and legal representation for the College) and are not open to the public. The only exception to this clause is when the College has been notified by law enforcement officials that criminal charges relevant to the case pending before the Committee have been filed against Respondent(s). In these instances, Respondent(s) may have an attorney present solely for the purpose of protecting Respondent(s) against self-incrimination in a future court proceeding. The attorney may not serve in any other capacity during the hearing including speaking on behalf of Respondent(s) or questioning/addressing those present. No disciplinary action will be taken unless it is established by a preponderance of evidence upon the record considered as a whole that the accused student has committed the charged offense. This clause

in no way limits the right of the College to have legal representation present at any hearing of the Judicial Committee.

The Chairperson of the Committee will file a report to the VPSA, VPAA, or Director of Residence Life of each case heard before the Judicial Committee that pertains to their department. These reports are to include a concise statement of charges, the plea, the decision of the Committee, the evidence considered and the reasons for the final action taken, if any. Findings and an explanation of decisions resulting from hearings will be rendered in writing within four (4) working days. The Judicial Committee may issue sanctions ranging from disciplinary warning to suspension and expulsion.

#### **Student Appeals**

An appeal does not provide a second hearing of the case. The review of the appeal will be based on the existing record, new information provided, as well as, information provided by the conduct officer regarding the rationale for the decision. Deviation from the procedures in this code will not invalidate a proceeding or decision or be a basis for appeal except where such deviation has clearly resulted in significant prejudice to an accused student.

#### A. Grounds of Appeal

- The established procedures were not followed in a <u>significant</u> way and as a result, the factual findings, the sanction, or both, were not correct.
- The severity of the sanction imposed was not appropriate based on the nature of the violation or the circumstances. In cases in which an accused student has accepted responsibility, such appeals are limited to having the severity of the sanction reviewed.
- There is new information that would have been material to the outcome, had the information been presented at the conference or hearing. The new information must be included with the student's request for appeal. Also, the student must show that the new information was not known to the person appealing at the time of the original hearing.

#### B. Process

A student will file the appeal by delivering it to the Office of VPSA (in cases involving student and/or residence life conduct) or the Office of VPAA (in cases involving academic integrity). In general, the filing of the appeal will result in a stay of the sanctions imposed on the appealing student, unless the welfare of an individual or the community is threatened. Students are encouraged to consult with all resources available to them prior to submitting the request for an appeal. The link to submit an appeal electronically is included in the decision letter, additionally a paper copy of the appeal form may be obtained from the Director of Student life.

If a student files an appeal, she/he will be informed of the outcome when the appeal process has been completed. Students must file their appeals within (4) four working days from the time they receive their decision or sanction letter or the opportunity to appeal is considered waived. (unless there is a special circumstance that would prevent this). An appeal will only be considered if it includes both the student's criteria and rationale for the appeal and an attached copy of the sanction decision letter. It is the student's obligation to provide any and all materials she/he wishes to have considered at the time of appeal submission. Subsequent information and/or revisions to the appeal will not be accepted.

The Student Conduct Committee (sub committee of Judicial Committee) will convene to resolve cases that meet criteria for an appeal. Appeals of decisions by the committee regarding suspension or expulsion will be heard by the VPSA (in cases involving student and/or residence life conduct) and the VPAA (in cases involving academic integrity). Such appeals from a student must be made in writing within four (4) working days of receipt of the Judicial Committee decision

The VPSA's and/or VPAA's decision will be considered final.

#### **Order of Business for Disciplinary Hearing Appeals**

Unless otherwise determined by the Chairperson of the Committee, the hearing will generally follow the order described below;

- A. Members of the Committee introduce themselves and ask all present to do the same.
- B. The Chairperson briefly reviews the hearing procedures as outlined here.
- C. The charges are read by the Committee Chairperson.
- D. The Complainant(s) will be the first to present testimony. At the conclusion of the Complainant(s)' testimony, the Complainant(s)' incident witnesses will each present testimony, with the Committee and Respondent(s) being permitted to ask questions.
- E. After the Complainant(s) have presented evidence to the Committee, the Respondent(s) will be given the opportunity to present personal testimony and the testimony of any incident witnesses' as described above. Following this testimony, the Committee and the Complainant(s) will be permitted to question the Respondent(s) and any incident witnesses appearing on behalf of Respondent(s).
- F. Character witnesses are not permitted at any disciplinary hearing.
- G. When all parties have presented their evidence, the Committee may ask further questions of any party and/or recall witnesses for further questioning. The Committee may call brief recesses at any time to discuss the proceedings and may ask further questions upon return from any such recesses.
- H. The Chairperson may also call witnesses, including expert witnesses from the College staff, to aid the Committee in its consideration of the case.
- I. When the Committee's questions have concluded, the Chairperson should inform the Complainant(s) and Respondent(s) that a written decision will be provided to them. The hearing will then be adjourned. The members of the Committee will meet in executive session to deliberate and render a decision.

#### **Basis for Findings: Standard of Evidence**

The standard or basis for findings refers to the criterion or measure of proof that is used to assess if a student is responsible for violating College policy.

The basis for findings used during any College judicial proceeding is a preponderance of the evidence. A finding, by a preponderance of the evidence, that a student violated College policy means that the Committee found that the evidence presented led to more than a 50% likelihood that a student is in violation of a regulation or standard. An easier way to think about this may be to consider the question, "Is it more likely than not that, based on the evidence and testimony presented to the Committee, the student violated the regulation or standard?" If the answer is "Yes," the Committee has achieved a preponderance of evidence.

The College uses a preponderance of the evidence as a standard of evidence for student disciplinary hearings because it is the basis for findings that is the most conducive to the academic setting and the educational process found in disciplinary hearings.

#### **Committee Education**

To ensure the college does not violate students' rights during the student conduct investigative and hearing process committee members will be required to undergo at least annual training related to their role as student conduct adjudicators. Such trainings will be provided by associations such as Association for Student Conduct Administration, National Association of Student Personnel Administrators, and other industry standard organizations offering conferences and webinars.

### **2020-2021** Area Updates:

### **Business Office**

- Finalized APS outsourcing and mapping integration with Microsoft Dynamics GP
- FY 2019-2020 Audit Wrapping up some minor requests and awaiting the ICC Foundation audit in order to complete our audit
- ➤ ERP Discovery Project In discussions with several vendors and have had discovery calls and deep-dive demos with campus stakeholders initial pricing received, currently in negotiations
- ➤ Budgeting Process for FY 21-22 Currently working toward a "carryover" budget and aggregating a list of mandatory cost increases Current state appropriations for FY 21-22 are estimated to decrease by 4%, and we will receive assessed valuation information from Montgomery County in June
- ➤ 21<sup>st</sup> Century Classroom Initiative We plan on partnering with faculty to equip their classrooms with all necessary equipment, infrastructure, and technology to provide maximum support and resources, regardless of modality
- ➤ All Long-Term Debt will be retired at the end of FY 22-23

#### Financial Aid

- ➤ Federal Work-Study Experimental Site Initiative Meetings are scheduled with the relevant Chambers of Commerce for an opportunity to create student employment positions with private employers
  - Our goal is to have ten positions in place by the end of FY 20-21 so that the open roles may be filled beginning in Fall 2021
- ➤ ICC has distributed over \$650,000 in direct grants to students via HEERF (Higher Education Emergency Relief Fund) funding
- Finalizing plans to utilize the third round of federal funding to provide relief for students with past due balances at ICC, allowing them to re-enroll in order to complete their degree
- Currently partnering with Executive Cabinet members to institute a new scholarship program that will attract students via additional tuition discounting





## Information Technology

- ➤ HP printer/copier fleet is fully rolled out, and all leased Xerox units have been returned to the vendor
- We are currently partnering with a vendor that will recycle old/depreciated equipment while providing payment to the college
- New antivirus (BitDefender) rollout is complete, which adds an additional layer of security for on-campus and remote work for employees
- Implementing a new ticket system to replace the Service Now Contract
- Launching KnowBe4 Cybersecurity training to help educate individuals on how to better identify phishing attempts, scam emails, and steps to take to safeguard sensitive information
- ➤ Completed new computer labs in the Academic and Fine Arts buildings
- > Weekly ticket resolution percentage has increased
- ➤ Door Access/RFID We are currently investigating timelines and costs for fully implementing RFID access throughout all ICC building
- We are conducting a campus grounds security survey to determine areas that require additional security cameras, both interior, and exterior
- Working on finalizing all necessary infrastructure and equipment upgrades for the E-Sports arena
- Discussing plans to create a small computer lab space for students in the dorms
- In the process of working with AmeriDyn (Microsoft GP consultant) and Ellucian to upgrade our existing database, which includes PowerCampus, PowerFAIDS, SQL Server, MS Server, and MS Dynamics GP. Microsoft has discontinued support for our current version, GP 2015, and the upgrade will install GP 2018 v2

#### **Campus Store**

- > The Bookstore has successfully implemented cashless payments for off-site events
- The team have streamlined the course material shipping process, reducing both delivery time and costs for students
- > Additional products have been added to the inventory, and we are seeing an increase in sales
- ➤ In the process of updating/refreshing the Bookstore ERP
- > We have upgraded the payment terminal in the store, which allows additional payment options for customers
- Investigating adding a "Book Drop" at the dorms
- Currently working on creating an electronic form for course materials to help streamline the adoption process for faculty

### Food Service

- Partnering with Student Affairs to create a campus-wide survey to gain better insight
- Michelle routinely meets with the Student Government Association to consider opportunities for improvement so that we can better serve our students
- > Dr. Bowhay and his team are currently working on a potential grant that could help fund capital improvements in the food service area, including minor remodeling and new furniture
- We have replaced several major appliances in the food service area, including a high-temp dishwasher and ovens, in order to better support their success





### **Campus Housing**

- Working with the housing team in order to identify additional staffing opportunities so that we can increase cleaning frequency and reduce the room turnover time
- Last FY, we replaced 1/3 of the aging mattresses in housing (many mattresses are original to the dorms), and we will continue a phased approach of replacing another 1/3 of the remaining mattresses
- ➤ Bluffstone will partner with ICC Marketing to better engage students

### **Campus Security**

- ➤ ICC has secured a full-time security associate to help patrol Main Campus, West Campus, the Dorms and assist our campus community with any needs
- We plan on having security partner with Student Affairs, Campus Housing, and Faculty to identify immediate needs, as well as determine short and long-term goals to better enhance safety across campus

### **Maintenance & Physical Facilities**

- ➤ The Maintenance team fully repaired the Field House bleachers internally, saving the college over \$24,000
- Minor remodel in AC110 to expand the classroom and refresh the area with new flooring and paint
- The Biology lab in the Academic Building was remodeled with new flooring, furniture, and equipment
- ➤ LED lighting upgrade The team has currently upgraded more than 130 light fixtures from fluorescent to LED, which will achieve substantial energy savings, long-term
- Currently replacing the entire stone façade at ICC West due to structural failure of the existing material
- In the process of renovating the lower level of the Student Union for the new E-Sports arena and the new Veterans Success Center
- Currently working on creating a HVAC replacement schedule for aging units Partnering with Trane to establish a recommended guide, phased-in cost approach, and migration from current BCS software to Trane software for both automated controls and diagnostics
- Establishing a deferred maintenance plan for buildings and parking lots include minor maintenance, such as painting, and major projects, including resurfacing and infrastructural upgrades
- Discussing a grounds maintenance initiative which includes cleaning the pond and reshaping the shoreline, applying weed control in main areas across campus, filling in rutted and uneven areas with topsoil, and seeding any barren soil across campus
