

Relevant Deadlines for Title IV Federal Student Aid by Term

Summer 2023

Summer 2023 requires 2022-23 FAFSA

- June 1, 2023: Priority deadline for ICC scholarships. Complete online application for scholarships at www.indycc.edu/financial-aid/forms. Awarded on a first-come, first-serve basis.
- June 5, 2023: Financial Aid Appeal Deadline for Summer 2023 June & full-Summer courses. Appeal and official college transcripts must be received by this date. **dates for midsession courses may vary; all appeals are due by the third date of courses for any session**
- June 12, 2023: June/Full summer session financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible **refund of aid by June 29th**
- June 24, 2023: June/Full summer session financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible **refund of aid by July 13th**
first-time loan borrowers enrolled in June/Full sessions subject to 30-day waiting period are eligible to receive loan funds on this date
- July 13, 2023: Summer sessions financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible **refund of aid by July 27th**
- July 29, 2023: Summer sessions financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **August 18th**. *First-time loan borrowers enrolled in July session only subject to 30-day waiting period are eligible to receive loan funds on this date*
- September 2023: Final 2022-23 Federal Student Aid Deadline published by Department of Education. No Federal Student Aid may be disbursed after this date.

Fall 2023

- Aug. 16, 2023: Financial Aid Appeal Deadline for Fall 2023 Full & First Session courses. Appeal and official college transcripts must be received by this date. **dates for mid-session courses may vary; all appeals are due by the third calendar day for any session**
- Aug. 21, 2023: Fall semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **September 22nd**
- Sept. 15, 2023: Fall semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **October 6th**
- Oct. 6, 2023: Fall semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **October 25th**
- Oct. 25, 2023: Fall semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **November 10th**

- Nov. 10, 2023: Fall semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **December 1st**
- Dec. 7, 2023: Last possible Date of Attendance for Full/First/Second session courses.

Spring 2024

- Jan. 19, 2024: Financial Aid Appeal Deadline for Full/First Session Spring 2024 courses. Appeal and official college transcripts must be received by this date. **dates for mid-session courses may vary; all appeals are due by the third calendar day for any session**
- Jan. 20, 2024: Spring semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **February 23rd**
- Feb. 23, 2024: Spring semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **March 8th**
- Mar. 8, 2024: Spring semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **March 29th**
- Mar. 29, 2024: Spring semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **April 19th**
- April 19, 2024: Spring semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **May 3rd**
- May 3, 2024: Spring semester financial aid priority deadline. Provide all requested documents to Financial Aid by this date to receive eligible refund of aid by **May 24th**
- May 9, 2024: Last possible Date of Attendance for Full/First/Second session courses.

Financial Aid Deadlines for Verification (if selected)

These are **strict deadlines**—failure to complete verification will prevent you from receiving a financial aid offer from ICC. See full deadline list at www.indycc.edu/financial-aid/deadlines.

Federal Pell Grant. To be considered for a Federal Pell Grant, students selected for standard verification must submit verification documents to ICC no later than 120 days after the last date of enrollment for the award year; **or** by the published date set by the Department of Education in September (whichever is the earlier of the two dates). Failure to meet this deadline will result in no Federal Pell Grant being disbursed to the student.

All Other Federal Student Aid. To be considered for other Federal Student Aid, verification must be complete and aid eligibility determined no later than the last date of enrollment. Student loans cannot be processed within the last two days of your last date of enrollment. Failure to meet this deadline will result in no other Federal Student Aid being disbursed to the student.

Verification of Identity and Educational Purpose. To be considered for any Federal Student Aid, students selected for verification of Identity and Statement of Educational Purpose must submit verification documents to ICC within 60 days of the first date the student is requested to submit the documentation. Failure to meet this deadline will result in the student's FAFSA being reported as 'No Response'. A student's verification status may be changed if verification documents are received no later than the last date of enrollment. Failure to meet this deadline will result in no Federal Student Aid being disbursed to the student.
